General Information about the course

- 1. Nowrosjee Wadia College has a Legacy of Excellence in Computer Science Education since 1986. It was the first college under Savitribai Phule Pune University to start the Bachelor of Computer Science (B.C.S.) course in 1986 (later renamed as B.Sc. (Computer Science). The Department has well-qualified, dedicated faculty members, and state-of-the-art infrastructure, Strong Industry-Academia connection with successful alumni, Dynamic curriculum covering core concepts and new technologies, Active training and placement cell for seamless academia-industry transition
- 2. As per the New Education Policy (N.E.P), B.Sc. (Cyber Security and Digital Forensics) is a 3/4 year undergraduate course. If a student completes 3 years of the course, he/she would be awarded B.Sc. (Cyber Security and Digital Forensics) degree and after the 4th year he/she would be awarded B.Sc. (Cyber Security and Digital Forensics) Honors degree.
- 3. B.Sc. (Cyber Security and Digital Forensics) is a **non-aided** (Self-financed) **course** conducted in **offline mode**
- 4. Nowrosjee Wadia College has one division for B.Sc. (Cyber Security and Digital Forensics) with a total intake capacity of 80 students

Eligibility

 The candidates who have passed XIIth Science from Maharashtra State Board or Equivalent examinations, and Mathematics as one of the subjects in class XII, are eligible for admission to this course. **Admission Procedure**

- 1) Admissions will be done on the Spot Round basis, in OFFLINE mode, at the Department of Computer Science.
- 2) The admission process will be done in the offline mode during the period from 09/09/2024 to 20/09/2024, during the Office hours. Stray cases will be considered until 25/09/2024, as per the decision of the College authorities.
- 3) Interested students are asked to visit the Department of Computer Science, for the admission process on or before Friday, 20th September 2024 up to 5.00 pm.
- 4) The applicant should submit the following documents at the time taking admission. (Documents should be clearly visible)
 - a) Marksheet of XIIth and Marksheet of Xth examination. (If a student has failed in subject(s) previously, then all marksheets of XIIth should be uploaded)
 - b) AADHAR CARD
 - c) Valid Caste Certificate, if applicable
 - d) If you are seeking admission through "Ex Serviceman, Defence, Sports and others Quota" or EWS etc. then relevant valid certificates are required
 - 5) Form filled in the wrong category, or not filled completely or correctly, or not having the appropriate documents specified above will be rejected.
 - 6) Admissions will be done strictly on spot round basis, considering all rules, regulations and reservation policies of Government of Maharashtra and Savitribai Phule Pune University
 - 7) The admission process will be conducted in the Department of Computer Science, during the Office hours. The student/guardian must be present with all relevant documents, at the time of admission process.
 - 8) The fees for B.Sc.(Cyber Security and Digital Forensics) will be notified, after the fee structure chart is approved by the college authorities.
 - 9) Scholarships for SC/ST candidates for this course are not yet sanctioned by the Government authorities of Government of Maharashtra .Hence, SC/ST students have to pay the full fees at the time of admission. The fees will be refunded to the concerned student's account if we receive approval from Government authorities. An undertaking regarding the same, must be given by the student to the department after taking admission.

- 10) If a candidate is given admission letter through the admission round and fails to pay the fees in the specified time, then his/her claim for the admission stands
- 11) Students must pay full fees at the time of admission to this course. Provisional admission or fee payments in installments is not allowed.
- 12) If any student cancels the admission, cancellation and refund rules of Government of Maharashtra and Savitribai Phule Pune University will be applicable.
- 13) The final decision regarding any admission will be with the College authorities.
- 14) The tentative date for the course commencement will be 01/10/2024.
